BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the portion of MIRAMAR ROAD, from the easterly boundary of Genesee Vista Subdivision across I-805 to the new alignment of Miramar Road, be and the same is hereby officially renamed EASTGATE MALL, as more particularly shown and described in Drawing No. 16422-D, on file in the office of the City Clerk as Document No. 751088, which shall govern as to all details therein.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to file a certified copy of this resolution in the offices of the County Clerk, County Recorder and County Surveyor of San Diego County.
