

RESOLUTION No. 213211


Adopted on MAY 8 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of GENE R. SCHNIEPP and IRENE L. SCHNIEPP, husband and wife as community property, executed in favor of The City of San Diego, bearing date of March 20, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto affecting Lot 12 and a portion of Lot 13 in Block 15 of Sorrento Lands and Townsite, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SORRENTO VALLEY ROAD.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
