LEGAL DESCRIPTION OF PROPERTY
TO BE SET ASIDE AND DEDICATED
IMPERIAL AVENUE

IMPERIAL AVENUE

All that portion of Lot 42 of Horton's Purchase, in the Ex-Mission Lands of San Diego, County of San Diego, State of California, State of California, according to Map thereof No. 283 filed in the Office of the County Recorder of San Diego County March 9, 1878, described as follows:

Beginning at a point 30.00 feet North and 260.00 feet East from the Southwest corner of said Lot 42, Horton's Purchase, Ex-Mission Lands; thence North $00^{\circ}52'58''$ East, 34.00 feet; thence South $89^{\circ}31'02''$ East, 43.57 feet to the beginning of a tangent 20.00 foot radius curve, concave Northwesterly; thence Easterly, Northeasterly and Northerly along the arc of said curve through a central angle of $89^{\circ}37'20''$ a distance of 31.28 feet to a point of cusp with the Westerly line of Ozark Street; thence South $00^{\circ}51'38''$ West, along said Westerly line of Ozark Street, 53.87 feet to an intersection with the Northerly line of Imperial Avenue; thence North $89^{\circ}31'02''$ West along said Northerly line, a distance of 63.46 feet returning to the Point of Beginning.
