

RESOLUTION No. 213220Adopted on MAY 8 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a parking time limit of two hours, between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on the following streets in said City:

- (1) West side of ROSECRANS STREET,  
between Talbot and Addison Streets.
- (2) East side of ROSECRANS STREET,  
between Talbot and Canon Streets.
- (3) South side of CANON STREET,  
between Scott and Evergreen Streets.
- (4) North side of CANON STREET,  
between Scott and Rosecrans Streets.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
