BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with RONALD E. PEKAREK for landscape architectural services required for the design of landscaping in various center islands and median areas in existing City streets under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 751188.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$200,000 is hereby authorized from the Gas Tax Fund (219), solely and exclusively, for the purpose of providing funds for the above referenced services and construction and related services for the following areas:

Fairmont Avenue:	Montezuma Road to Alvarado Canyon Road
Genesee Avenue:	Balboa Avenue to Sauk Avenue

Park Boulevard:	University Avenue to Howard Avenue

College Avenue:	I-8 to Del Cerro Boulevard
Grand Avenue:	Bond Street to Figueroa Boulevard
Imperial Avenue:	63rd Street to Foster Street
Main Street:	Intersection at Schley Street
Nimitz Boulevard:	Tennyson Street to West Point Loma Boulevard
