WHEREAS, a \$300 rental fee is required to be paid for use of the Stadium parking lot; and

WHEREAS, the City considers this charitable event to be exceptionally desirous; and


WHEREAS, as a result, the City desires to cosponsor such event to the extent of the rental fee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That The City of San Diego will cosponsor with the Cystic Fibrosis Foundation an Auto Cross driving event at the San Diego Stadium parking lot on June 1, 1975.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby directed to transfer the sum of \$300 from the Unallocated Reserve (53.30) to the Stadium Operations Fund (256) to be used solely and exclusively for cosponsorship payment of the rental fee.
