

RESOLUTION NO. 213292 R. 75-2393
MAY 15 1975

WHEREAS, Resolution No. 183271 of the City Council authorized the Director of Utilities to furnish water to one S. HOLDERNESS, a customer of the Otay Municipal Water District outside City boundaries, subject to certain conditions, one of which was that said water service was to be only for a period of five years commencing with the date of said resolution; and

WHEREAS, Resolution No. 199349 of the City Council extended the water service to S. Holderness for an additional five years, under the same terms and conditions as set forth in Resolution No. 183271; and


WHEREAS, that condition has caused the authorization under Resolution No. 199349 of the City Council to expire on March 30, 1975; and

WHEREAS, the City Manager has recommended that said water service be continued to S. HOLDERNESS under the same terms and conditions as set forth in Resolution No. 183271 for an additional five years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 199349 be amended to provide that the Director of Water Utilities be and he is hereby authorized to furnish water service to S. HOLDERNESS until June 30, 1980, subject to all other terms and conditions as set forth in Resolution No. 183271.
