RESOLUTION DESIGNATING THE BOUNDARIES OF THE WATER ACTIVITY ZONES.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 63.20.2(b) of the San Diego Municipal Code, the boundaries of the water activity zones are designated as follows:

1. BATHING AND SWIMMING ZONE:

- a. The waters of the beach area between the westerly extension of the southern line of Santa Monica Avenue and the westerly extension of the southern line of Cape May Avenue.
- b. The waters of the beach area between the westerly extension of the northern line of San Gabriel Place and the westerly extension of the northern line of Ventura Street.
- c. The waters of the beach area between the westerly extension of the southern side of Oliver Street and the westerly extension of a line 75 feet south of the southern side of Garnet Avenue.
- d. The waters of that area known as Children's

 Pool and being on the inside of the breakwater established
 at said point.
- e. The waters that are known and designated as La Jolla Cove.

- f. The waters of the beach area between the westerly extension of a line 125 feet north of the southern side of Avenida de la Playa and the westerly extension of the northern side of the La Jolla Shores lifeguard station.
- 2. BATHING AND SWIMMING ZONE SEASONAL (Effective June 1 through September 30 only):
 - a. The waters of the beach area between the westerly extension of the southern side of Santa Clara Place and the westerly extension of the northern side of Tangiers Court.
 - b. The waters of the beach area between the westerly extension of the southern side of Palomar Street and the westerly extension of the northern side of Playa del Norte Street.

3. BOARD SURFING ZONE:

- a. The waters of the beach area between the westerly extension of a line 75 feet south of the southern side of Niagara Street and the westerly extension of the southern side of Santa Monica Avenue.
- b. The waters of the beach area between the westerly extension of the southern San Diego flood control jetty and the westerly extension of the southern Mission Bay channel jetty.
- c. The waters of the beach area between the westerly extension of the northern Mission Bay channel jetty and the westerly extension of the line 200 feet

south of the southerly side of the South Mission Beach lifeguard station.

- d. The waters of the beach area between the westerly extension of the northern side of Ventura Street and the westerly extension of the southern side of Jersey Court.
- e. The waters of the beach area between the westerly extension of the northern side of San Juan Place and the westerly extension of the southern side of Santa Clara Place.
- f. The waters of the beach area between the westerly extension of the northern side of Windemere Court and the westerly extension of the southern side of Oliver Street.
- g. The waters of the beach area between the westerly extension of the northern side of Missouri Avenue and the westerly extension of the northern boundary of Tourmaline Canyon Surfing Park referred to as Sungold Point.
- h. The waters of the beach area between the westerly extension of the northern side of Playa del Norte Street and westerly extension of the northern side of Nautilus Avenue.
- i. The waters of the beach area between the westerly extension of the northern side of the La Jolla Shores Lifeguard Station and the westerly extension of the southern side of Camino del Collado Street.

4. CONTROL ZONE:

- a. The waters of the beach area between the westerly extension of the northern side of Cape May Avenue and the westerly extension of the southern San Diego flood control jetty.
- b. The waters of the beach area between the westerly extension of a line 200 feet south of the southerly side of the South Mission Beach lifeguard station and the westerly extension of the southern side of San Gabriel Place.
- c. The waters of the beach area between the westerly extension of the southern side of Jersey Court and the westerly extension of the northern side of San Juan Place.
- d. The waters of the beach area between the westerly extension of the northern side of Tangiers Court and the westerly extension of the southern side of Windemere Court.
- e. The waters of the beach area between the westerly extension of a line 75 feet north of the northern side of Garnet Avenue and the westerly extension of the north side of Missouri Avenue.
- f. The waters of the beach area between the westerly extension of the northern side of Nautilus Avenue and the westerly extension of the northern side of Westborne Avenue.

g. The waters of the beach area between the westerly extension of the southern side of Camino del Collado Street and the westerly extension of the southern property line of Scripps Institute of Oceanography UCSD.

5. NO BOARD SURFING ZONE:

- a. The waters of the beach area between Children's Pool and Goldfish Point, excepting therefrom the waters of La Jolla Cove, which are a BATHING AND SWIMMING ZONE.
- b. The waters of the beach area between the westerly extension of the southern side of the Marine Room and the westerly extension of the southern side of Avenida de la Playa.

6. BOAT LAUNCH ZONE:

a. The waters of the beach area between the westerly extension of the southern side of Avenida de la Playa and the westerly extension of a line 125 feet north of the southern side of Avenida de la Playa.

7. CLOSED ZONE:

- a. The waters of the beach area between the westerly extension of a line 75 feet south of the southern side of Niagara Avenue and the westerly extension of a line 75 feet north of the northern side of Niagara Avenue.
- b. The waters of the beach area between the westerly extension of a line 75 feet south of the

southern side of Garnet Avenue and the westerly extension of a line 75 feet north of the northern side of Garnet Avenue.

BE IT FURTHER RESOLVED, that, pursuant to to Section 63.20.2(b) of the San Diego Municipal Code, the effective dates for all CONTROL ZONE and BATHING AND SWIMMING ZONE - SEASONAL, shall read "Effective June 1 through September 30."

BE IT FURTHER RESOLVED, that Resolution No. 180140 as amended passed by this Council on May 28, 1964 be, and the same is hereby rescinded.
