

RESOLUTION NO. 213308

WHEREAS, the San Diego City Council on November 21, 1974, voted unanimously to direct the City Manager to include an annual statement with water bills indicating what part of the water bill is attributable to Metropolitan Water District and San Diego County Water Authority taxes; and

WHEREAS, such statement has not been issued; and

WHEREAS, memoranda and reports released by the City Manager and the City Attorney indicate that perhaps the Manager does not intend to issue such statement; and

WHEREAS, there is no informational, mechanical nor procedural impediment preventing the easy issuance and distribution of such statement; and

WHEREAS, such statement is simple, factual information revealing only what the bill payer is paying for, and which information is proper and right for them to have; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby directed to comply with the direction of the City Council of November 21, 1974, to include an annual statement with water bills, without further delay.
