
RESOLUTION NO. 213310

BE IT RESOLVED, by the Council of The City of San Diego that the Chief of Police is requested to exercise his discretion as permitted under Sections 57.01 A and 57.01.23 (14) of the San Diego Municipal Code to waive the stipulated percentage of 50% as the maximum cost of solicitation for a charitable event in order to allow a San Diego Charger Exhibition Game to be played and advertised this summer as a charitable event benefiting four local youth organizations, to wit: Big Brothers of San Diego; Boys' Clubs of San Diego, Girls' Clubs of San Diego and Neighborhood House Association.

BE IT FURTHER RESOLVED, that the Council believes that there exists, in this particular case, good cause for the aforementioned waiver.
