

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City an agreement with the consulting firm of McMANIS ASSOCIATES, INC., Management and Research Consultants, 1120 Connecticut Avenue, Northwest, Washington, D.C. 20036, for the purpose of designing and developing a citizens participation program in the City of San Diego, for the total amount of \$33,500.00, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 751382.

BE IT FURTHER RESOLVED, that the expenditure of \$2,712.00 is hereby authorized out of Community Development Block Grant Fund 2910 of The City of San Diego, solely and exclusively for the purpose of reimbursing the Planning Department for Project Management costs.
