WHEREAS, The City of San Diego is the owner of a certain open space easement on Lots 2 and 7 of La Jolla Golf and Tennis Club Unit No. 1, according to Map thereof No. 7858 filed January 31, 1974 in the office of the County Recorder; and

WHEREAS, the Engineering and Development Department has requested that the City quitclaim to MARINE BUILDERS COMPANY, INC., a California corporation, city's interest in and to said easement to allow better utilization of said land; and

WHEREAS, the City desires to negotiate the sale of said easement to MARINE BUILDERS COMPANY, INC., a corporation, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permits the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the value of the property right sought, as determined by a staff appraiser of said City, is the sum of sixty-five dollars (\$65); and

WHEREAS, no real estate broker's commission shall be paid; and WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No.

751366 , quitclaiming to MARINE BUILDERS COMPANY, INC., an easement for open space purposes over Lots 2 and 7 of La Jolla Golf and Tennis Club Unit No. 1, as more particularly described in said form of quitclaim deed.

- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
