BE IT RESOLVED, by the Council of The City of San Diego as follows:


That subject to the Appropriation Ordinance for Fiscal 1975-76, the continuation of the City's Dial-a-Ride Program in Fiscal 1976, with service to be limited to the handicapped and senior citizens (60+ years) and provided in an expanded service area in accordance with Alternative 3 of the City Manager's report of April 21, 1976, be and it is hereby approved.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to prepare a detailed budget for Fiscal 1976 for said program.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to prepare and transmit to all interested parties a Request for Proposals which would provide for the operation of this Dial-a-Ride Program by private enterprise and present the response(s) to said Request for Proposals to this City Council within ninety (90) days of the date of this resolution.
