That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE STATE OF CALIFORNIA for construction of erosion control facilities in Torrey Pines State Park Reserve, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 751363.

BE IT FURTHER RESOLVED, that the expenditure of \$11,250 is hereby authorized out of Environmental Growth Fund 2505 of The City of San Diego, solely and exclusively for the purpose of providing funds for the City's share of the above-referenced project.
