

RESOLUTION NO. 213367

WHEREAS, members of the City Council of The City of San Diego, the City Attorney and the City Manager are frequently required to travel within the greater metropolitan area of the City of San Diego in order to attend meetings and perform other duties in the discharge of their offices; and

WHEREAS, the only convenient and expeditious means of transportation available to these officials are either their personal automobiles or automobiles placed at their disposal by the City; and

WHEREAS, it has long been the policy of the City that each member of the Council, the City Attorney and the City Manager shall have at their disposal automobiles in which to travel as required in the proper discharge of their official duties; and

WHEREAS, the constantly increasing geographic size and population of the City require greater expense by these officials in the discharge of their official duties; and

WHEREAS, previous resolutions of this Council have determined and set a fair average amount representing personal automobile expense paid by each of these officials in the discharge of his official duties; and

WHEREAS, it is the continuing policy of the City to recognize the necessity for each member of the Council, the

City Attorney and the City Manager to have at their disposal automobiles in which to travel incident to the discharge of their official duties; and

WHEREAS, it is also the continuing policy of the City to recognize that these officials should be reimbursed for such necessary expenditures; and

WHEREAS, Resolution No. 205015, adopted February 29, 1972, established the sum of two hundred sixteen dollars (\$216) per month reimbursement for automobile expenses incurred in the operation of their personal automobiles in the performance of their official duties, and in lieu of said sum each such official so electing would receive fifty-two and 75/100 dollars (\$52.75) per month and have placed at his disposal a City-owned or leased automobile to be used in the performance of his official duties; and

WHEREAS, a review by the Financial Management Department has determined that the only cost factor seriously out of line is the gasoline allowance which provides justification to increase said allowance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That each member of the City Council, the City Attorney and the City Manager shall continue to receive the sum of two hundred sixteen dollars (\$216) per month as reimbursement for expenses necessarily incurred in the operation of their personal automobiles in the performance of their official duties, and in lieu of the sum of two hundred sixteen dollars

(\$216) per month reimbursement for automobile expenses, each such official so electing shall receive the sum of sixty-three and 90/100 dollars (\$63.90) per month and shall have placed at his disposal a City-owned or leased automobile to be used in the performance of his official duties.

BE IT FURTHER RESOLVED, that Resolution No. 205015, passed and adopted February 29, 1972, is hereby rescinded.
