
Adopted on MAY 27 1975

That Resolution No. 211715, adopted October 3, 1974, be and it is hereby amended to authorize the City Auditor and Comptroller to transfer an additional two thousand dollars (\$2,000) from the Unallocated Reserve (53.30) to Allocated Reserve (53.20) to provide additional funds to defray the expenses involved in defending The City of San Diego, William Sage, Auditor and Comptroller, and Gordon Feeley, Treasurer, in Superior Court Case No. 358163, L.
