WHEREAS, the City's Management Team and representatives of Local 145, International Association of Fire Fighters (herein called "IAFF"), have been meeting and conferring in regard to noneconomic matters; and

WHEREAS, the Management Team and IAFF have reached agreement in regard to authorization for deductions from wages and salaries of employees authorizing same in writing for payment of assessments by IAFF and have agreed to submit to the City Council a noneconomic Memorandum of Understanding to such extent; and

WHEREAS, the noneconomic Memorandum of Understanding has been reduced to writing and the parties desire the endorsement and approval of the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Council of The City of San Diego hereby endorses and approves the noneconomic Memorandum of Understanding agreed to by the Management Team and representatives of IAFF pertaining to deductions from salaries and wages of employees who authorize in writing such deduction for payment of assessments by IAFF pursuant to the provisions of the [REDACTED] Memorandum of Understanding on file in the office of the City Clerk as Document No. 751414.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller  
be and he is hereby authorized to make such deductions pursuant  
to the terms of the Memorandum of Understanding.

BE IT FURTHER RESOLVED, that Resolution No. 95122 dated  
September 13, 1949, be and the same is hereby rescinded.
