BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE STATE OF CALIFORNIA, DEPARTMENT OF WATER RESOURCES which would allow the City to purchase miscellaneous water transportation facilities relating to the Saline Water Conversion Test Facility on South San Diego Bay, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 751371.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of nine thousand one hundred ninety-five dollars (\$9,195.00) within the 500 Fund from Unallocated Reserve (67.49) to Water Mains and Valves (66.40) for the purpose of providing funds to be used solely and exclusively for the above project.
