APPROVING MAP OF WILMAR UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, Registered Civil Engineer, entitled "WILMAR UNIT NO. 1 Being a subdivision of a portion of the east half of the Southeast Quarter of Section 6, T15S, R2W, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to the United States Government Survey approved February 19, 1883.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Miramar Road, and a portion of Black Mountain Road and a portion of Kearny Mesa Road for public purposes, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
