
Adopted on MAY 29 1975

REYES, a widow, executed in favor of The City of San Diego, bearing date of April 7, 1975, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, across a portion of Lot 53 of Horton's Purchase in the Ex-Mission Lands of San Diego, according to Map thereof No. 283, filed in the office of the San Diego County Recorder March 9, 1878, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE.

That the City Clerk of said City is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director of said City for further handling.
