
Adopted on MAY 29 1975

HOLMAN, husband and wife as to an undivided one-half interest, executed in favor of The City of San Diego, bearing date of April 3, 1975, conveying to said City for street and slope purposes a portion of Lot 61 of a portion of Ex-Mission Lands of San Diego, commonly known as Horton's Purchase, according to Map thereof No. 283, filed in the Office of the County Recorder of San Diego County March 9, 1878, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.
