RESOLUTION NO. 213419

MAY 30 1975

WHEREAS, Section 26.02 of the Municipal Code established an Historical Site Board and authorized the Board to cause the withholding of demolition permits for designated historic sites for a reasonable period of time; and

WHEREAS, Section 26.02 E.4. provides that prior to taking action necessary to preserve an historic site on which a demolition permit is being withheld, the Historical Site Board must submit a proposed plan for preservation to the City Council; and

WHEREAS, the Historical Site Board caused a proposed plan for preservation of the Red Rest and Red Roost in La Jolla to be submitted at the April 23, 1975 meeting of the Council and the tentative plan was approved by the Council; and

WHEREAS, said Municipal Code section provides that at the end of thirty days the Historical Site Board shall report its progress to the City Council, which may upon review of the progress report, withdraw and cancel the objection to the proposed demolition and authorize the issuance of necessary permits; and

WHEREAS, by document dated May 2, 1975, a copy of which is on file in the office of the City Clerk as Document No. 751455, the Historical Site Board communicated the following conclusions:

1. Onsite preservation with public funds is not a practicable proposal.
2. An officer of the Save Our Heritage Organization indicated that the Organization might raise between

\$10,000 and \$15,000 towards the relocation and/or preservation of these buildings.


3. Federal assistance money, if available at all, would not be available earlier than late 1976.
4. The owner has stated that he has not been contacted, does not wish to sell the property, and would need to be notified by the City of an attempt to condemn.
5. Relocation of the property to City park lands has received no support within the park advisory structure. The Historical Site Board does not recommend that the cottages be relocated to City park lands.

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the report of the Historical Site Board, dated May 2, 1975, with regard to the Red Rest and Red Roost is hereby accepted.

BE IT FURTHER RESOLVED, that pursuant to Section 26.02 E.4. of the Municipal Code, objection to the issuance of demolition permits for the Red Rest and Red Roost is hereby withdrawn and cancelled.
