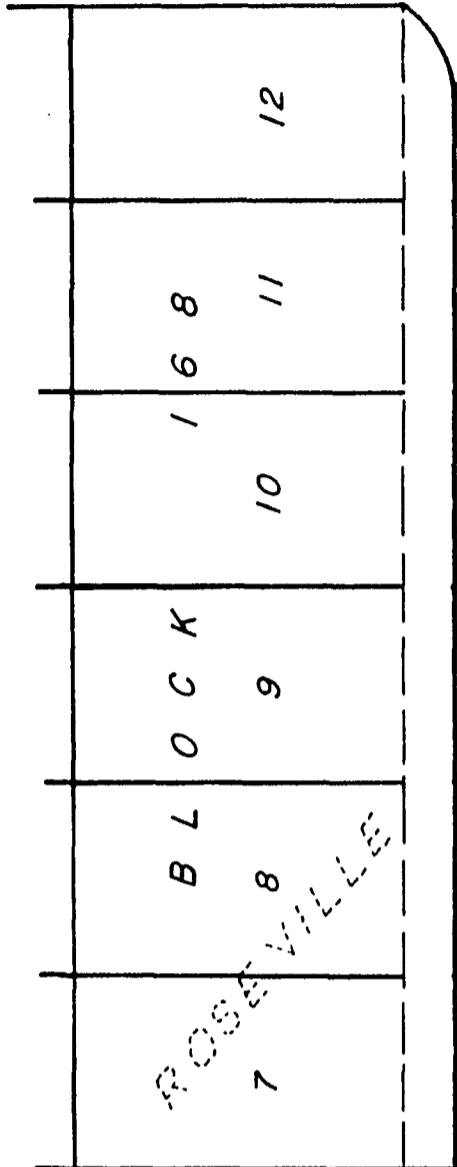

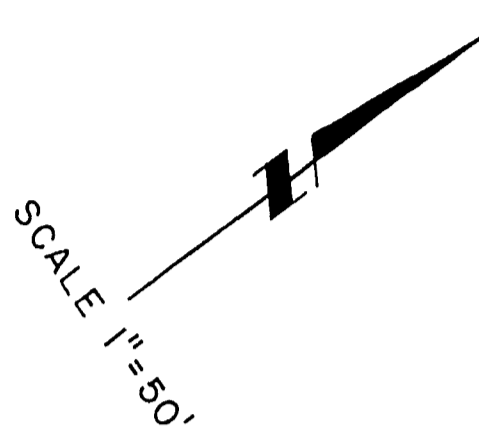
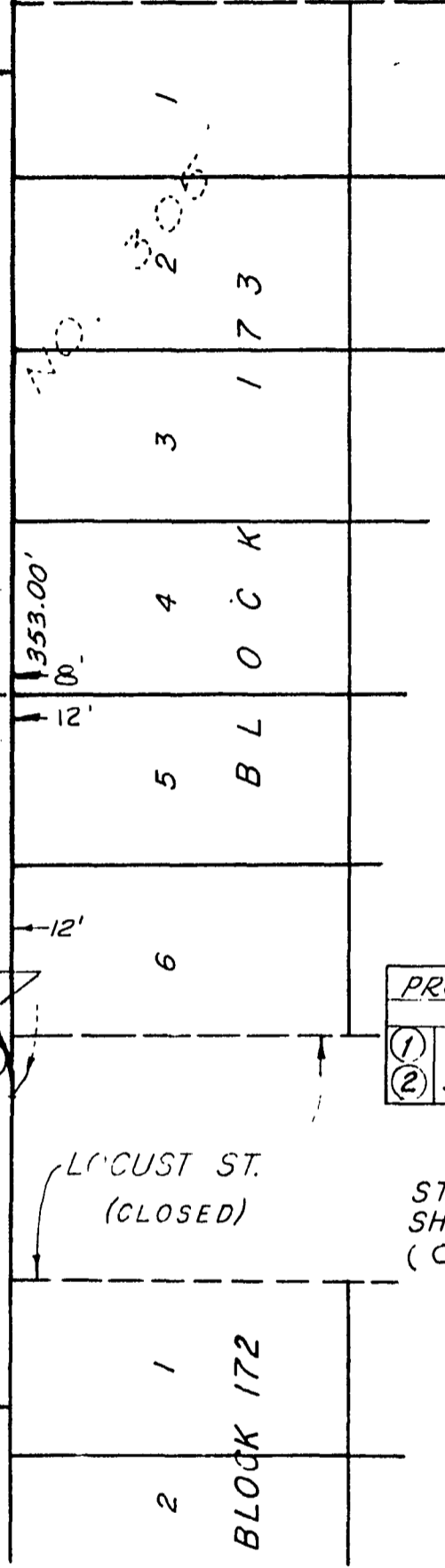

(CLOSED)




UDALL STREET
