Kunkel	POLICE DEPARTMENT	\$665	<p>A little more than a year ago, Officer Kunkel proposed that crimes occurring on school property be reported by school security personnel, and that Police Officers not be called to investigate and make reports. This was at first turned down.</p> <p>Last October, 1974, the idea was reopened for consideration, and school security personnel agreed to try the arrangement. After about five months, the results were reviewed and found not only beneficial to the San Diego Police Department, but better for school personnel.</p> <p>Crimes against persons are still handled by San Diego Police, but the saving on all other cases amounts to \$6670 per year.</p>
