BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the contribution of \$112.50 from the Tecolote Pony League for CONSTRUCTION OF APPROXIMATELY 400 FEET OF 4' CHAIN LINK FENCE and REPAIR OF A 6' CHAIN LINK FENCE at Tecolote Park is hereby accepted.
2. That the expenditure of \$112.50 is hereby authorized from Capital Outlay Fund (Fund No. 245) as the City's share of the improvement cited above.
3. That the bid of Atlas Fence is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing labor and materials for the CONSTRUCTION OF APPROXIMATELY 400 FEET OF 4' CHAIN LINK FENCE at \$3.70 per foot, and REPAIR OF A 6' CHAIN LINK FENCE for a lump sum of \$145.00 at Tecolote Park, for a total estimated cost of \$1,625.00; terms net 30 days.
