

RESOLUTION No. 213453


Adopted on JUN 5 1975

That the acceptance by the City Manager of that deed of WAYNE and WANDA GOLDIE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of April 11, 1975, conveying to said City for street and slope purposes a portion of Lot 60 of Sunshine Gardens, according to Map thereof No. 1804 filed in the Office of the San Diego County Recorder on August 27, 1924, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the City Clerk of said City is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
