1. The appeal of ELIZABETH JOAN HAGGIN, by E. F. Cook, agent, from the decision of the City Engineer in denying her application for an encroachment permit (Application No. 6745) to install and maintain a wall, fencing, barbecue, covered patio and sauna pool within the public right of way on a portion of Lot 6, Block 117, Roseville, located on Willow and Macaulay Streets, be and it is hereby granted.

2. The City Engineer is hereby instructed to issue an encroachment permit to Elizabeth Joan Haggin to install and maintain a wall, fencing, barbecue, covered patio and sauna pool.

3. Property owners are hereby directed to initiate street vacation proceedings, through the City Manager, and have said proceedings completed by June 30, 1976.
