WHEREAS, on November 20, 1973, the City Council authorized by Resolution No. 209290 a consultant agreement with Robert M. Epler, Inc. for the purpose of studying the feasibility of self-insuring the City's group health insurance program; and

WHEREAS, on August 27, 1974, the consultant, in conjunction with a Special Task Force Committee (herein called "Committee") which was organized to conduct an analysis of self-funding recommended that the City self-fund its health plan and enter into an "administrative services only" (ASO) contract with an independent organization qualified in such respect; and

WHEREAS, on December 19, 1974, the City Council authorized the Manager to self-fund the City's Group Health Indemnity Plan and further authorized the solicitation for proposals by advertisement for an ASO contractor; and

WHEREAS, the City advertised for proposals in accordance with Council authorization on January 30, 1975; and

WHEREAS, five ASO proposals were received and reviewed by the Committee and the San Diego Foundation for Medical Care was determined by the Committee to offer the best claim control and to be most responsive to the criteria established by City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an Administrative Services Only (ASO) agreement with the San Diego Foundation for Medical Care to administer the City's CITYMED Plan, pursuant to the terms and conditions of the form of ASO agreement on file in the office of the City Clerk as Document 751529 No.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$303,024.51 from the Deposit Trust Fund 3021 to the CITYMED Health Plan Fund 873.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$17,964.55 from the Unallocated Reserve (53.30) to the CITYMED Health Plan Fund 873, said funds representing interest previously earned on health funds invested.

BE IT FURTHER RESOLVED, that the City Treasurer be and he is hereby directed to deposit all future earnings on Health Plan Fund 873 investments back to the credit of Fund 873 to be retained and used solely for purposes of said fund.
