

**RESOLUTION No. 213481**Adopted on JUN 5 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 72.07(a) of the San Diego Municipal Code, taxicab stands be and the same are hereby established on the following street locations in said City:

- (1) A two-cab stand to be located in front of the Municipal Traffic Court at 8950 Clairemont Mesa Boulevard.
- (2) A one-cab stand to be located on the south curb line of El Cajon Boulevard approximately 100 feet east of 60th Street and prior to a driveway entrance to a major food store parking area.
- (3) A one-cab stand to be located at parking meter No. 11-924 on the southwest corner of Eleventh Avenue at Broadway.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and that the taxicab stands hereinabove established shall become effective upon the installation of such signs.
