BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an Offer of Grant from the Economic Development Administration, Department of Commerce, in the amount of \$306,500 (one-half total project cost of \$613,000) to assist in the financing of off-site improvements for the Market Street Industrial Park, Project No. 07-01-01628, said Offer of Grant is on file in the office of the City Clerk as Document No. 751485.

BE IT FURTHER RESOLVED, that the expenditures of \$56,500 from Community Development Block Grant Fund 2910 and \$250,000 from Model Cities Fund 2903 of The City of San Diego are hereby authorized, solely and exclusively, for the above-mentioned project.
