RESOLUTION NO. 213513

APPROVING MAP OF SAMPO SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM S. KROOSKOS, Registered Civil Engineer, and entitled "SAMPO SUBDIVISION Being a subdivision of a portion of Lot 63 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Partition Map thereof made in the action of Juan M. Luco, et al., vs., Commercial Bank of San Diego, et al., and on file in the office of the County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street that portion of Lot 1 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 66477.2 of the Government Code of the State of California.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of slope rights, as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and said Council has rejected that portion of Lot 1 marked "Reserved for Future Street" shown on this map within this subdivision; and that that certain easement with the right of ingress and egress for the construction and maintenance of slope rights as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
