

RESOLUTION NO. 213540 R. 75-2234
JUN 12 1975

WHEREAS, MRS. ONELIA M. RIVERA, dba Multilingual Guide Service, has applied to the City Council for two Certificates of Public Convenience and Necessity to operate automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(1) The service the applicant desires to perform is a city-wide bilingual tour service promoted through travel agencies. There appears to be a need for this type of service, since no other licensed auto-for-hire firm provides a bilingual tour service;

(2) The proposed auto-for-hire service will not conflict with existing taxicab, auto-for-hire, or bus service;

(3) The applicant appears to be financially responsible and has two years previous experience conducting a similar business;

(4) The vehicles to be used are two white and blue 1975 fifteen-passenger Dodge Sportsman vans. These vehicles have been satisfactorily inspected by the Police Department;

(5) It has been determined that the service will not significantly add to traffic congestion;

(6) This additional service within the City will not result in a greater hazard to the public;


(7) Mrs. Rivera's personal and business references have been checked satisfactorily; and

WHEREAS, the Council this date, after a public hearing has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Mrs. Onelia M. Rivera, dba Multilingual Guide Service, having filed an application for two Certificates of Public Convenience and Necessity to operate automobiles for hire pursuant to the provisions of Section 72.11 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, two Certificates of Public Convenience and Necessity are hereby granted to Mrs. Onelia M. Rivera to operate the vehicles specified in the application subject to compliance with all provisions of the San Diego Municipal Code.
