That the bids of 1. Master Truck, a Division of Hallamore, Inc., and 2. Utility Trailer Sales Company are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of EIGHTEEN (18) CAB AND CHASSIS AND EIGHTEEN (18) REFUSE BODIES, as follows:

1. Master Truck, a Division of Hallamore, Inc. for EIGHTEEN (18) CAB AND CHASSIS at a cost of \$25,088.00 each, terms net 15 days plus sales tax, less trade-in allowance of \$300.00 each for used City equipment.
2. Utility Trailer Sales Company, for EIGHTEEN (18) REFUSE BODIES at a cost of \$10,982.00 each, terms net 30 days plus sales tax.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$71,000.00 from 100 Fund Unallocated Reserve to the 522 Fund, Dept. 88.50 for this purpose.
