

RESOLUTION NO. 213543

WHEREAS, an application for transfer of two certificates of public convenience and necessity from Mr. Harry Cook to MR. THEODORE P. JARDINE, JR., dba de Touring Company, to operate automobiles for hire within the limits of the City of San Diego has been received; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(a) The service the applicant desires to perform is to continue providing sightseeing tours on a scheduled basis using fixed routes of travel. There appears to be a continued demand for this service.

(b) Because this is a request to transfer two existing certificates of public convenience and necessity, no conflict with existing taxicab, autos for hire, or bus service should occur.

(c) The applicant appears to be financially responsible and has previous experience in a similar business.

(d) The vehicles that are to be used will be the same as approved for the previous owner. These vehicles have been satisfactorily inspected by the Police Department.

(e) Being an existing business, no additional traffic congestion will occur.

(f) Being an existing business, this service will not result in a greater hazard to the public.


(g) Mr. Jardine's personal and business references have been checked satisfactorily.

WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the transfer of the two certificates of public convenience and necessity for automobiles for hire, as more particularly set forth above, be and it is hereby granted, subject to compliance with all provisions of the San Diego Municipal Code.
