BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY, for the engineering design and construction of automatic crossing gates at NOELL STREET (Crossing No. 2-265.4), in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 752317.

2. That the expenditure of \$30,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the design, construction and related costs for the above-referenced project.

3. That the City Manager be, and he is hereby authorized to request reimbursement from the California Public Utilities Commission for one-half of the actual cost of the City's share of the above-referenced project.
