BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City's delegate to the Comprehensive Planning Organization (CPO) be and he is hereby directed to seek those amendments to CPO's Fiscal Year 76 Final Program Budget contained in the Planning Director's May 16, 1975 memorandum to Council entitled "Budget and Work Program Proposal for CPO Plan Refinement," a copy of which is on file in the office of the City Clerk as Document No. 751607, and in the Rules Committee Consultant's May 16, 1975 memorandum to the Rules Committee entitled "Report on CPO Administrative Budget Increases," a copy of which is on file in the office of the City Clerk as Document No. 751608.

BE IT FURTHER RESOLVED, that the City's delegate to the CPO be and he is hereby directed to request the CPO staff to submit a statement to the City explaining the apparent inequity in salaries for CPO staff compared to City staff.

BE IT FURTHER RESOLVED, that the City's delegate to the CPO be and he is hereby directed to request the CPO staff to submit the City's proposed amendments to CPO's Fiscal Year 76 Budget to the CPO Board of Directors pursuant to the Board resolution adopted on May 12, 1975 inviting budget comments from CPO member agencies.
