BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO to implement the 1975 Summer San Diego Recreational Support Program with funds in the amount of \$360,000 to be drawn from the Human Care Services Trust Fund, said contract is to meet the approval of the City Attorney, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 751599.

BE IT FURTHER RESOLVED, that upon the condition that said money is available and said contract with the County of San Diego is approved by the City Attorney, the City Manager is further authorized and empowered, for and on behalf of said City, to execute 69 agreements with community and governmental agencies to carry out the 1975 Summer San Diego Recreational Support Program, pursuant to the terms and conditions set forth in the form of agreements on file in the office of the City Clerk as follows:
