2. That the expenditure of \$456,500.00 is hereby authorized from Sewer Revenue Fund (Fund No. 506) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SEWER MAIN REPLACEMENT GROUP 35 - MONTGOMERY PALISADES TRUNK SEWER in the City of San Diego, and related costs.
