WHEREAS, Economic Development Corporation (hereafter EDC) has been working with the Southern Pacific Railroad in a joint effort to create an industrial park in South San Diego; and

WHEREAS, the project has been designated the South San Diego Industrial Park and it is proposed that an industrial park of approximately 50 acres of MIP zoning be created; and

WHEREAS, while it will be one industrial park, the sites will be plotted in such a way that the City of San Diego and the Southern Pacific Railroad will retain separate areas; and

WHEREAS, the firm of Lawrence, Fogg, Smith & Associates, consulting civil engineers, have been selected as the planning consultant for this project in as much as they have done a substantial amount of preliminary work on this project under contract to Southern Pacific; and

WHEREAS, this proposal will provide funds for completion of a tentative map, preparation of zoning application, preparation of environmental assessment, boundary and topographical surveys, filing fees and other related costs to bring the project to the point at which bids could be taken for the building of streets and leveling of pads; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure not to exceed fifty thousand dollars (\$50,000)

from Trust Fund No. 314 for the purpose of paying expenses in connection with subdividing into South San Diego Industrial Park the 25.93 acre parcel of City-owned property located in Southbay, adjacent to and westerly of National Avenue between Fern and Iris Avenues, is hereby approved and authorized.
