prospective public street purposes.

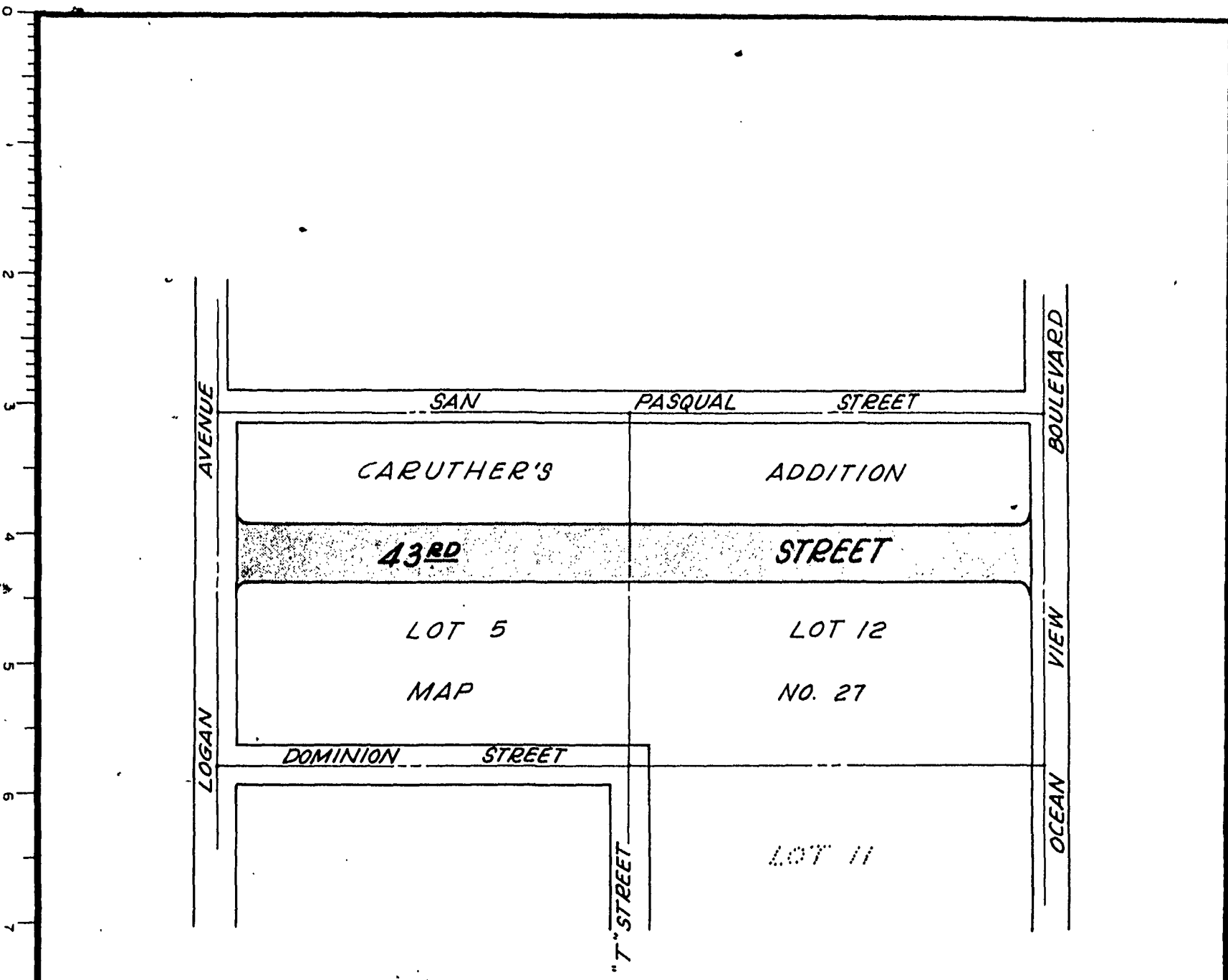
BE IT FURTHER RESOLVED, that 43RD STREET between Logan Avenue
