WHEREAS, The City of San Diego is the owner of a portion of Lots 25 and 26, Block 2, Reed and Hubbell's Addition, according to Map thereof No. 327, together with a portion of Marcy Avenue, now vacated and closed to public use; and

WHEREAS, the San Diego Gas & Electric Company, a corporation, has requested the conveyance of an easement for power line purposes over and across said property to serve a City library; and

WHEREAS, the purposes for which the easement is required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation;
NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That, in consideration of the benefits to accrue to the people of said City, the Mayor and the City Clerk of said City be, and they

are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for power line purposes over and across a portion of Lots 25 and 26, Block 2, Reed and Hubbell's Addition, together with a portion of Marcy Avenue as vacated and closed to public use, as more particularly described in said form of Deed of Easement on file in the office of the City Clerk as Document No. 761739.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
