BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to negotiate contracts with eleven Human Care Services programs for the purpose of continuing their operation for a period of ninety (90) days which shall be for the time period between July 1, 1975, through September 30, 1975, with fiscal year 1976 funds from Department No. 05.61. Said programs to be extended for three months are Barrio Station, Bridges to Business, Community Organization, Legal Aid, Narcotics Abuse Prevention, Project Orgullo, Project Seniority, Reintegration of Ex-Offenders, Senior Citizens Manpower Employment, Special Services and Young Unwed Mothers.

BE IT FURTHER RESOLVED, that said eleven contracts shall be approved by this Council prior to their execution.

BE IT FURTHER RESOLVED, that the City Manager shall evaluate each of these programs during said three-month period and prepare a report to the City Council prior to the end of said three-month period which evaluates said programs, levels of funding, alternative programs and makes further recommendations as to future uses of Revenue Sharing funds for human care programs.
