1. That the bid of \$22,900.00 by Taber Electric, a corporation, for CONSTRUCTION OF SKYLINE PARK & RECREATION CENTER AND AZALEA PARK - SAFETY AND RECREATION LIGHTING in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 750757.
2. That the expenditure of \$29,000.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) of the City of San Diego, and that the expenditure of \$2,230.00 is hereby authorized from Park Service Fund (Fund No. 11690) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SKYLINE PARK & RECREATION CENTER AND AZALEA PARK - SAFETY AND RECREATION LIGHTING in the City of San Diego, and related costs.
