WHEREAS, The City of San Diego is one of the original members of the Town Affiliation Association (now generally designated as "Sister Cities International"), the national organization which provides the framework for sister city relationships under the program founded by President Eisenhower; and

WHEREAS, San Diego has the opportunity this year to compete for the 1977 Conference of Sister Cities International which is actively sought by Los Angeles, San Jose, Portland and other western cities; and

WHEREAS, the decision will be made at the conference this August 6 through August 9 in Rochester, New York; and

WHEREAS, convention registration provides a nominal amount of subsidy for administration and essentials, but is purposely kept moderate to encourage participation of persons who must bear their own expenses; and

WHEREAS, it is anticipated that the sum of \$7,500 will be required from The City of San Diego for such administrative and miscellaneous expenses; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That this Council does hereby support and endorse the efforts of the San Diego Sister City Society to attract the 1977 Conference of Sister Cities International to San Diego.

BE IT FURTHER RESOLVED, that the Council does hereby express its intention to set aside and allocate in the Fiscal Year 1977 budget the sum of \$7,500 from Transient Occupancy Tax Funds (223) to be used solely and exclusively for the above purpose.
