That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with SAN DIEGO SYMPHONY ORCHESTRA ASSOCIATION, a nonprofit California corporation, for the presentation of a minimum of twenty-five concerts, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 751795.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby fully authorized and directed to set aside the sum of \$50,000 from the Transient Occupancy Tax Fund (223) Contingency Reserve (52.29) to be used solely and exclusively for the above purpose.
