
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to submit, for and on behalf of said City, three grant applications to ACTION and if grants be awarded according to the terms and conditions in said grant applications, the City Manager is hereby authorized to execute grant acceptance documents in order to implement three interrelated social service programs, said applications are set forth below and are on file in the office of the City Clerk as follows:

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$31,600 from General Fund 100, Human Resources Department, to Trust Fund 3021, to be reserved for these programs, and said funds shall be incumbered for expenditure if said grant awards are made pursuant to all terms and conditions contained in the grant applications.
