That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with HARRY E. FARB, whereby City leases a portion of Lots G, H and I, Block 80, Horton's Addition, to be used for office space for a term of five years commencing July 1, 1975, at a monthly rental of \$2,150.00, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 751776.

That the expenditure of not to exceed \$25,800 from Fund 2884 is hereby authorized to be used solely and exclusively for the above stated lease purposes.
