That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with VTN CONSOLIDATED, INC. for performance of preliminary engineering studies and preparation of environmental impact analyses for two sanitary landfill sites, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 751780.

BE IT FURTHER RESOLVED, that the expenditure of \$8,000 and \$42,000 is authorized out of Capital Outlay Fund 245 and Federal Revenue Sharing Fund 2384, respectively, of the City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
