RESOLUTION MAKING APPLICATION FOR FOUR  
GRANTS FOR LAUNCHING FACILITIES FROM THE  
DEPARTMENT OF NAVIGATION AND OCEAN  
DEVELOPMENT.

WHEREAS, The City of San Diego is desirous of improving four launching facilities in the Mission Bay Park area to meet the boating needs of the people of San Diego; and

WHEREAS, the State Department of Navigation and Ocean Development provides launching facility grant funds to counties, cities and districts for the construction, enhancement or rehabilitation of small craft launching facilities; and

WHEREAS, The City of San Diego has conducted a feasibility report which shows the proposed projects to be engineeringly and financially feasible and economically justified; and

WHEREAS, The City of San Diego is willing to enter into a construction and operation agreement to provide for the maintenance and operation of the proposed facilities; NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego by the adoption of this resolution hereby makes application to the Department of Navigation and Ocean Development for four grants for the purpose of improving small craft launching facilities in the Mission Bay Park area to wit: (1) Santa Clara Point, (2) Dana Basin, (3) DeAnza Cove, and (4) Ski Beach.


