

RESOLUTION No. 213674Adopted on JUN 26 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with the SAN DIEGO UNIFIED PORT DISTRICT, a public corporation, whereby City leases approximately 7,000 square feet of storage space in the basement of the Port District Building for City records and office space for records personnel for a term of five years commencing October 1, 1975 and terminating September 30, 1980, at a monthly rental of \$620, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 751789.

That the transfer of \$10,000 from 100 General Fund Unallocated Reserve to the City Clerk's Budget (Dept. No. 03.30) is hereby approved and authorized.

That the expenditure of not to exceed \$36,100 from 100 General Fund to provide for the above stated lease purposes is hereby approved and authorized.
